Add a Joint Cardmember

Build a bigger dividend as your family members (or anyone else you choose) enjoy the convenience of making purchases with an REI Visa card.

A Joint Cardmember (a.k.a. secondary card member) is a person you add to your REI Visa card account who will be jointly liable for any balance owed on your account.

- By signing, the Joint Cardmember agrees to the terms of the Cardmember Agreement. The Cardmember Agreement will arrive with the additional REI Visa card.
- The terms and conditions of your account will remain the same.

For your protection, we require your written authorization to add an individual to your account and we require the signature and agreement of the Joint Cardmember. To request an addition, fax or mail this completed form back to us at the address noted below.

IMPORTANT INFORMATION ABOUT OPENING A NEW ACCOUNT

To help the government fight the funding of terrorism and money laundering activities, Federal law requires all financial institutions to obtain, verify, and record information that identifies each person who opens an account. What this means for you: When you open an account, we will ask for your name, street address (P.O. Boxes are not allowed under Federal law), date of birth, and other information (including your Social Security Number or Tax Payer Identification Number) that allow us to identify you. We may also ask to see your driver's license or other identifying documents when appropriate.
